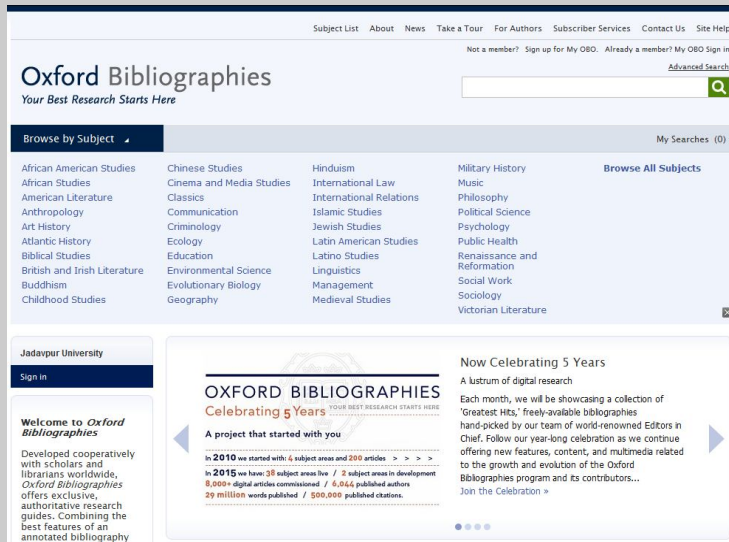

Brief History

It started its journey in 2010 with only 4 subject area and 200 articles. Then in 2015 it expanded with 38 subject area, 8000+ articles and 5000000 citations.

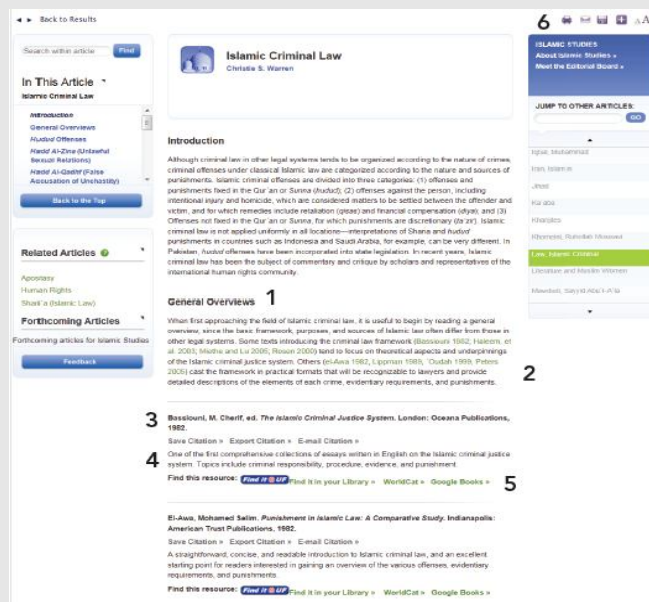
Scope and Coverage

Oxford University Press published a product called Oxford Bibliographies Online. These are lengthy annotated bibliographies, written by scholars,

on various topics. Its user-friendly interface and quick links help users directly to the information, that they are looking for—whether it's a chapter, book, journal article, Website, blog, or data set. Features such as saved searches, personalized citation lists, and other links to full-text print and online content allow users to quickly and easily meet desired information and find supplemental materials. It provides 24*7 hr. access to expert research recommendations in over 5,000 subjects across nearly 40 academic disciplines (more being added each year also). The Oxford Bibliographies is updated regularly, with 50-75 articles added per year to each subject area. It covers various subject areas like Art History, Atlantic History, Biblical Studies, British and Irish Literature, Buddhism, Childhood Studies, Chinese Studies, Cinema and Media Studies etc.

Kind of Information

In Oxford Bibliographies each article, written and reviewed by top scholars in the particular field, is rich with citations and annotations, expert recommendations etc. An anatomy for an article with description is given below through print screen.

Oxford Bibliographies in Ecology is an extensive, annotated bibliography of the most important concepts and ideas in the discipline. Ecology is a wide-ranging field that has its roots in the observations and writings of the early plant geographers, including of course Charles Darwin. As ecology has developed it has drawn from classical 'hard sciences' such as chemistry and physics, but has its own unique identity and today brings in modern aspects of many other disciplines including other areas of the life sciences, and geography, mathematics, computing and statistics. Ecology itself forms the underpinning of Environmental Science. And so, ecology has much to offer. For *Oxford Bibliographies in Ecology*, topics from all the relevant areas have been selected; these include articles on autoecology, population, community, and ecosystem ecology, the main biomes of the world, as well as articles related to the synthesis of ecology with other disciplines including human ecology, agroecology, and chemical ecology, for example.

Arrangement Pattern

This Oxford Bibliographies primarily arranged in broad subject wise. Under a particular subject entries are arranged in alphabetic order. For example under the subject 'Anthropology' the entries are arranged in alphabetical sequence. A clear example (print screen) is given below.
