Kind of Information The encyclopedia includes articles on various concepts on philosophy and also includes biography of philosophers in ancient and in modern time from different regions of world.

Each entry related to a particular concept on philosophy gives an introduction on that concept. Then gives content where the article includes different topics related to the concept.

As for example an entry on "Sankhya" first gives an introduction on the Sankhya school of philosophy and its origin of development and then includes a content (the following screen shot) where the important topics (hyperlinked) related to Sankhya philosophy is included and the article gives information on that topics.

The article after giving descriptions on the above shown topics includes the list of references suggested for further reading. The encyclopedia also includes name, email Id, credential of the author.

The entry when gives biographical information on a philosopher, gives it with an image and includes a content of topics and the article gives information on those topics.

As for example the entry on "Immanuel Kant" includes a long introduction and includes information on his personal life and includes his philosophical theories.

Special Features

- The submission and review process of articles is the same as that with printed philosophy journals, books and reference works.Submissions are peer reviewed by specialists according to strict criteria.
- The encyclopedia is connected to their Facebook, Twitter pages to share information.

	 The encyclopedia gives a list of desired articles on their home page. It also gives hyperlinked list of recently included articles. It holds ISSN 2161-0002. The encyclopedia includes coloured and black and white JPEG images.
Arrangement Pattern	The articles are searched by A to Z alphabetic hyperlinked list. The articles also can be browsed by categories and sub categories which are arranged in alphabetical sequence. Below is given the alphabetic listing of categories (e.g. History of Philosophy, Metaphysics and Epistemology etc.) and within it the sub categories (like Epistemology, Metaphysics, Mind & Cognitive Science etc.) are also shown.

Remarks

The IEP which is free of charge receives no funding from their users and available to all internet users worldwide. The purpose of the IEP is to provide detailed, scholarly information on key topics and philosophers in all areas of philosophy. The Encyclopedia's articles are written with the intention that most of the articles can be understood by advanced undergraduates majoring in philosophy and by other scholars who are not working in the field covered by that article. The IEP articles are written by experts but not for experts in analogy to the way the *Scientific American* magazine is written by scientific experts but not primarily for scientific experts. The peer review process is rigorous and meets high academic standards. More specifically, an author submits an article to a specific IEP area editor, who reads through the article and makes an initial judgment about its overall quality. Many submissions are rejected at this stage. The encyclopedia does not compromise the quality of the articles.
