

- *Kind of Information* Government Documents Resources gives the opportunity to search & know government documents subjects wise through the links that are provided in supporting each subjects. They are depicted below.

Defense and International Relations: It gives the opportunity to know about defense, U.S. Foreign Policy, & statistics. Each of the categories is sub-divided into many sub-categories. Visitors can get any information related to it after selecting a particular link.
