Brief History

The Ministry of Statistics and Programme Implementation came into existence as an Independent Ministry on 15.10.1999 after the merger of the Department of Statistics and the Department of Programme Implementation.

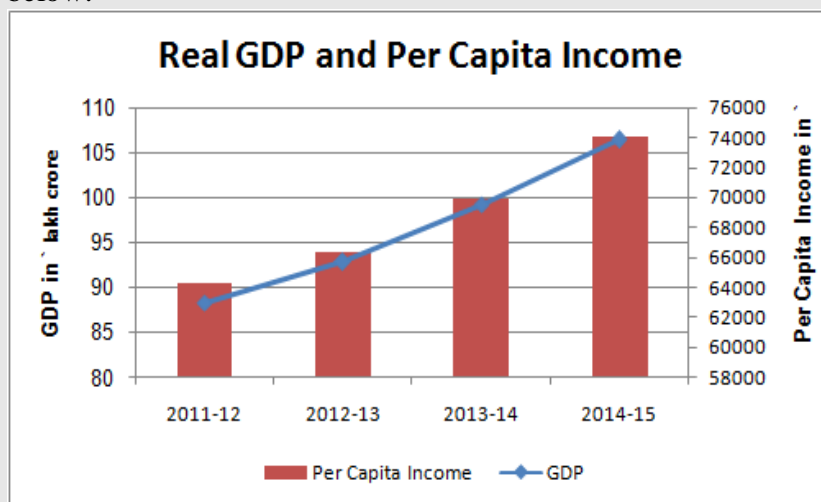
Scope and Coverage

The Ministry has two wings, one relating to Statistics and the other Programme Implementation. The Statistics Wing called the National Statistical Office (NSO) consists of the Central Statistical Office (CSO), the Computer Centre and the National Sample Survey Office (NSSO). The Programme Implementation Wing has three Divisions, namely, (i) Twenty Point Programme (ii) Infrastructure Monitoring and Project Monitoring and (iii) Member of Parliament Local Area Development Scheme. Besides these two wings, there is National Statistical Commission created through a Resolution of Government of India (MOSPI). The Ministry attaches considerable importance to coverage and quality aspects of statistics released in the country. The statistics released are based on administrative sources, surveys and censuses conducted by the Centre and State Governments and non-official sources and studies. The Ministry's officials have been associated with international agencies on the development of methodologies, particularly in the areas of national accounts, informal sector statistics, large-scale sample surveys, conduct of censuses, service sector statistics, non-observed economy, social sector statistics, environmental statistics and classifications.

Kind of Information

It provides information on Members of Parliament Local Area Development Scheme (MPLADS). It also gives emphasis on the Results-Framework Documents (RFD). As per Government's instruction, all Ministries / Departments are required to prepare a RFD consisting of the priorities set out by the Ministry concerned, corresponding success indicators and time bound targets to measure progress in achieving their objectives.

Graphical presentations of statistical data are given here. One of such presentations are shown below:



Directory of officials are given in tabular format. Generally lists of office of ministers, office of secretaries, Central Statistics Office (CSO), National Sample Survey Office (NSSO) etc. are found here. An example is given below:

Instructions are also provided on how to conduct a survey. The Ministry maintains an 'Advance Release Calendar' for its data categories covered under Special Data Dissemination Standards (SDDS), which is disseminated on the Ministry's website as well as on the Dissemination Standards Bulletin Board. The Ministry releases the datasets covered under the Real Sector of SDDS through press notes and its web-site simultaneously. Brief information are given on important projects like International Cooperation and Partnership, Support for Statistical Strengthening (SSS),

It conducts large scale all-India sample surveys for creating the database needed for studying the impact of specific problems for the benefit of different population groups in diverse socio-economic areas, such as employment, consumer expenditure, housing conditions and environment, literacy levels, health, nutrition, family welfare, etc. The Data Centre of the Ministry is operational round the clock i.e. 365x24x7 basis to facilitate the users.
