Brief History

The Philippine Statistics Authority (PSA) was created on September 12, 2013 when the Philippine Statistical Act of 2013 (Republic Act No. 10625) was signed by President Benigno S. Aquino III. The new government authority was created by merging the National Statistics Office, the National Statistical Coordination Board, the Bureau of Agricultural Statistics and the Bureau of Labor and Employment Statistics.

Scope and Coverage

It covers information on national censuses and surveys, sectoral statistics, consolidation of selected administrative recording systems and compilation of national accounts. It collects, compiles, analyzes, makes abstract and publishes statistical information relating to the country's economic, social, demographic and general activities and condition of the people. It is also engaged to prepare and conduct statistical sample surveys on all aspects of socioeconomic life including agriculture, industry, trade, finance, prices and marketing information, income and expenditure, education, health, culture, and social situations for the use of the government and the public. It coordinates with government departments and local government units (LGUs) on the promotion and adoption of statistical standards involving techniques, methodologies, concepts, definitions and classifications, and on the avoidance of duplication in the collection of statistical information.

Kind of Information

It gives statistical figures on different sectors and those can be seen by scrolling up & down. Examples are given below:

Latest news and updates of PSA are given in descending chronological order. Information on Philippine Statistical System (PSS), statistical laws, Philippine Statistical Development Program (PSDP), System of Designated Statistics (SDS) etc. Statistics are given on different areas like economic, social, multi sectoral etc. including their micro categories.

It gives list of statistical database including logos and brief description as shown below:






Datasets can be browsed by different categories. Those categories can be identified by particular icons as can be seen below:



It also gives information on CountrySTAT which can be considered as a web-based system that integrates national food and agricultural statistical information to ensure harmonization of national data and metadata collections for analysis and policy making. Data can be found after selecting country, year, field and period. Data can be seen in tabular format like:



Regions can be selected from the given maps and statistics on different fields are given in tabular format including their graphical representations. Such as, economy of Davao city shows the following result:



It also gives information on news, events, press releases, articles etc. It gives description on several types of classification systems. Some of those are given below:

- Philippine Classification of Individual Consumption According to Purpose (PCOICOP)
- Philippine Standard Classification of Education (PSCEd)
- Philippine Standard Industrial Classification (PSIC)
- Philippine Standard Geographic Code (PSGC)
- Philippine Standard Occupational Classification (PSOC)

Yearbooks are given on many topics. Some of those are: Philippine Statistical Yearbook (PSY), Philippine Industry Yearbook of Labor Statistics (PIYLS), Gender Statistics on Labor and Employment (GSLE) etc.
