Scope and Coverage	The volumes are rich with all India and state level time series data, cross sectional data with commentaries indicating global and domestic environment, Government policies and interventions that shape various sectors, international comparisons, historical trends and current performance. References and sources of data are provided. To contextualize the performance of various sectors in India, chapter wise commentary has been suitably modified to include global and domestic scenario, Government policies and interventions that mould various sectors, international comparisons, historical trends etc besides the current performance of the country. Considering the huge size of the content and also to reduce the carbon footprints, this yearbook publication has been made available online at <u>www.mospi.nic.in</u> . The publication provides data not only on various facets of the economy of the country, but also vital developmental aspects of the country like its housing, health, infrastructure, tourism and crime.
Kind of Information	At the home page of the Ministry of Statistics and Programme Implementation the latest yearbook, namely "Statistical Year Book, India 2016" is found. To access yearbooks of preceding years, one has to input the search "Statistical Year Book, India" with the year (e.g. 2015, 2014, 2013) s/he needs to find. Each chapter of a concerned yearbook is arranged serially at the homepage of the yearbook. A chapter opens up to a page showing the subsections of the chapter. The information on the subsections are contained in Excel files linked to the titles of the subsections. Example is given below:
	A chapter in the yearbook "India, G20 and the world" (Chapter 1) is divided into the below mentioned areas:
	Export Growth And Share In World Export: India And Other Countries (1.1), Human Development Index And Its Components (1.2), Area, Population and Income Of G-20 Countries (1.3), Human Development Index And Its Components : G - 20 Countries (1.4) etc.
	The first subsection, "Export Growth And Share In World Export : India And Other Countries " contains table of data (Table 1.1) in an MS-Excel file depicting export growth of

	countries and their share in world export in descending order. The table is designed with the name of the country and their year wise value of growth in US\$ Billion, growth rate in percentage, CAGR (Compound Annual Growth Rate), share in the world exports in percentage and change in share. Countries are arranged in order of their export growth and share in world exports. In the Table 1.1 China is placed at the top of the table for its highest growth in the export. One can find the value of the export growth of China, 1202 and 1578 US\$ Billion in the year 2009, 2010 respectively, the CAGR of 1993 and 2000 to 2008 being 25.4 and 24.4. Growth rate in percentage for year 2008, 2009, 2010, 2011 (Jan – June) is 17.3, -15.9, 31.3, 24.0 respectively. Sources of information are available with each table. Access to the commentaries on the global and domestic environment, government policies and interventions shape various sectors, international comparisons, historical trends and current performance are not available.
Special Features	 Data tables are available in Excel files. The user can easily organize the data as per requirements. Link to the list of officers and staff associated with the publication of the yearbook. Data driven yearbook.
Arrangement Pattern	 Each yearbook can be found separately through internet search with the title and the particular year of the yearbook (Statistical Yearbook India 2015). The topics of a yearbook are mentioned chapter wise with serial numbers. The topics are arranged as per the editor's discretion. The chapter "India G 20 and The World" has been described through the following subsections arranged thematically: 1.1Export Growth And Share In World Export : India And Other Countries 1.2 Human Development Index And Its Components, 1.3Area, Population And Income Of G-20 Countries, 1.4Human Development Index And Its Components : G-20 Countries Each subsection then opens up to an Excel file containing tables of data as shown below:
